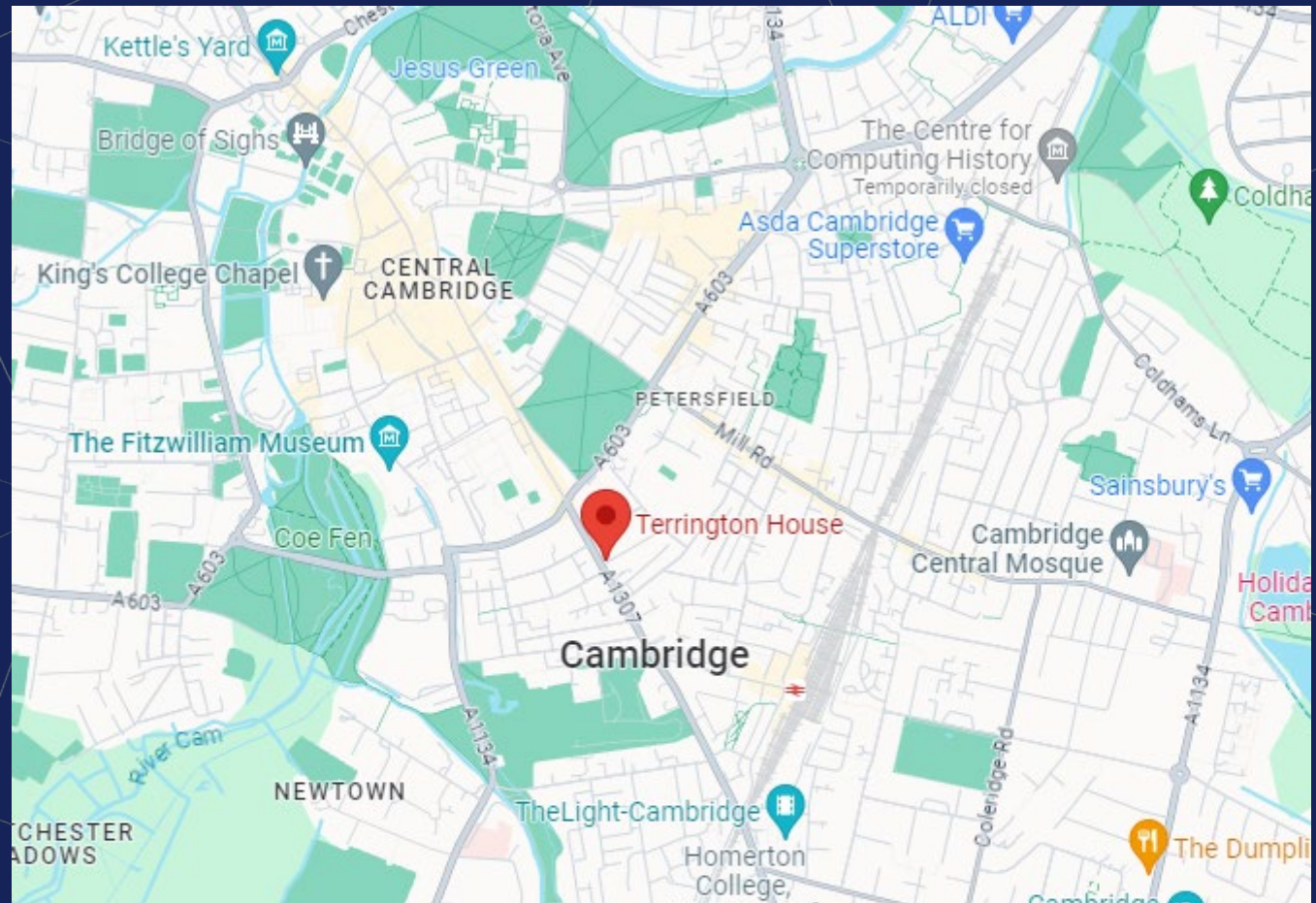
LOCATION

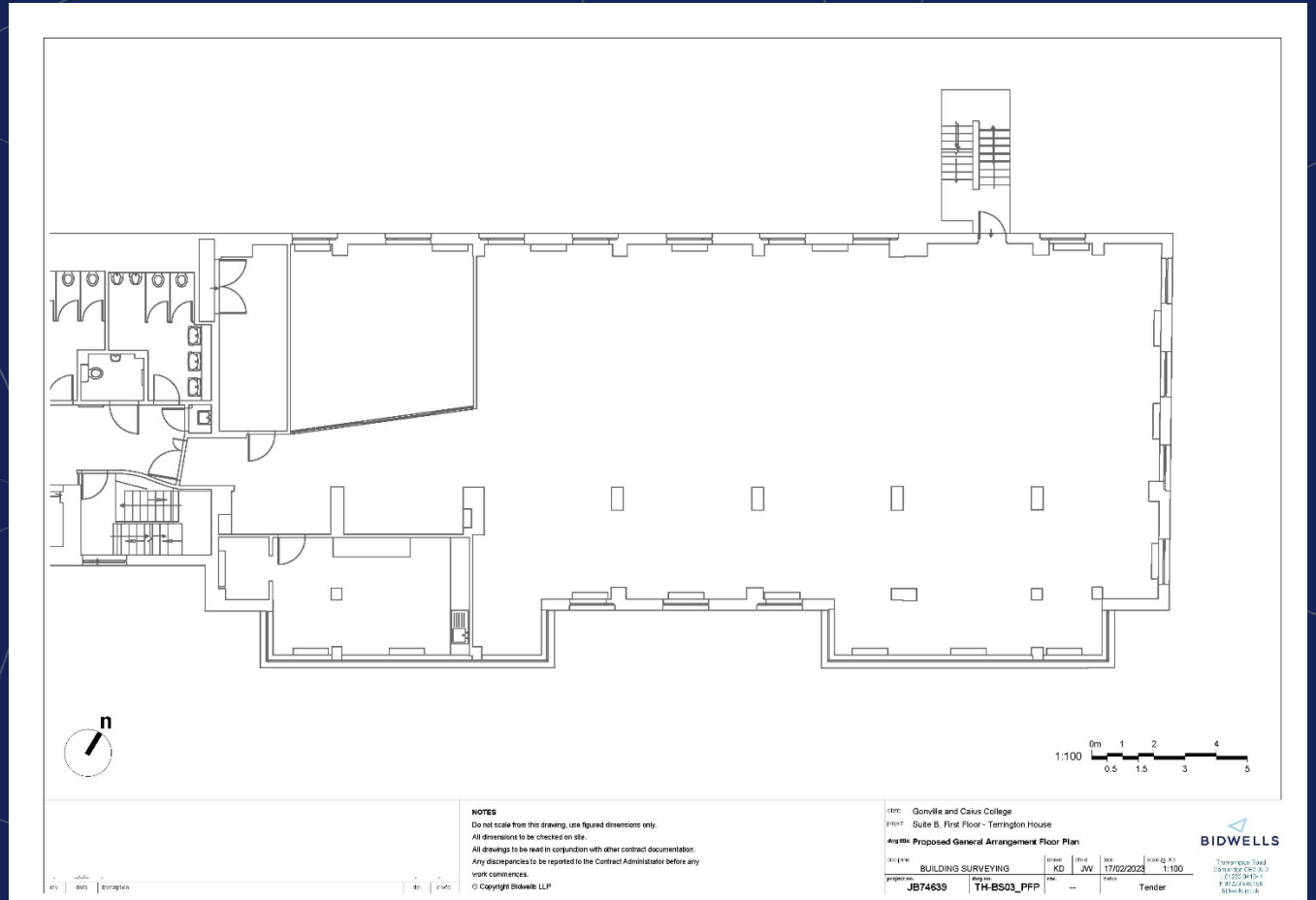
